#### Note:

- 1. Foreign students invited to Taiwan for short-term study programs: The scholarship for exchange students will be granted for a maximum of one year and for research interns will be granted for a period of one to six months, both can not be divided or extended.
- 2. Scholarship recipients should abide by the following requirements:
  - (1) They should complete the short-term study program under the agreement before they return to their country.
  - (2) The purpose for the residence of research interns in Taiwan is limited to internship.
  - (3) An experience report of the exchange program or research internship (including photos) must be submitted before the end of the exchange or research internship. The Academy may use the report on a public platform as an introduction to the results.
  - (4) Research interns should deliver at least one progress report of the internship to an audience of students from relevant research laboratories.
  - If a scholarship recipient violates the relevant regulations, the Academy will rescind the scholarship.
- 3. If a scholarship recipient is found to have violated academic ethics, the ROC law, or NCKU

regulations during the duration of scholarship, and the Academy resolves to discontinue the scholarship, the Academy shall cease to issue the scholarship from the immediate following month.

- 4. Scholarship recipients who are found to have submitted forged or untruthful documents will be disqualified from the scholarship award. The scholarship that has been granted should be returned while relevant obligations will be investigated according to the circumstances.
- 5. During the scholarship period, the supervisors need to receive the students, and the academy can provide assistance as follows:
  - (1) Provide students with relevant information on accommodation in Tainan.
  - (2) Assist in arranging activities related to research and exchange in the academy.
