Operating Rules for Direct Admission to Doctoral Programs of the NCKU Academy of Innovative Semiconductor and Sustainable Manufacturing

- 一、國立成功大學(以下簡稱本校)智慧半導體及永續製造學院(以下簡稱本學院),為辦理學生 逕行修讀博士學位作業,依據國家重點領域產學合作及人才培育創新條例第23條及教育部 「學生逕修讀博士學位辦法」,訂定「國立成功大學智慧半導體及永續製造學院學生逕行修 讀博士學位作業規定」(以下簡稱本規定)。
- I. In order to conduct operations of direct admission to doctoral programs, The Operating Rules for Direct Admission to Doctoral Programs of the NCKU Academy of Innovative Semiconductor and Sustainable Manufacturing (hereafter the Rules) are established by the Academy of Innovative Semiconductor and Sustainable Manufacturing (hereafter the Academy), National Cheng Kung University (NCKU) in accordance with Article 23 of National Key Fields Industry-University Cooperation and Skilled Personnel Training, and the Direct Pursuit of Ph.D. Degree Regulations (學 生逕修讀博士學位辦法) promulgated by the Ministry of Education (MOE).
- 二、經教育部核可之國內外大學或獨立學院應屆畢業學士班學生、碩士班研究生,合於逕行修 讀博士學位資格者,得申請逕行修讀本學院博士學位。
- II. Undergraduate program students in the current graduating class, or master's program students from MOE-accredited domestic or overseas universities/colleges, who meet the designated qualifications of direct-admission to doctoral programs are entitled to apply for direct admission to doctoral programs of the Academy.
- 三、申請逕行修讀博士學位學生,由原就讀或相關系、所、院、學位學程助理教授以上二人推 薦,向本學院學位學程提出申請。

申請逕行修讀博士學位學生資格如下:

- (一)學士班應屆畢業生(含申請提前畢業生)具下列條件之一者:
 - 1. 學業成績平均75分以上。
 - 2. 名次在該班(或系)學生前 60%以內。
- (二) 碩士班修業一學期以上且學業成績具下列條件之一者:
 - 1. 學業成績平均80分以上。
 - 2. 名次在該班(或所/學程)學生前 60%以內。

申請逕行修讀博士學位學生應繳資料如下:

- (一) 報名表(於學院學程網頁下載)。
- (二) 推薦信(原就讀或相關系、所、院、學位學程助理教授以上二人推薦)。
- (三) 學士班應屆畢業生:大學成績單;
- (四) 碩士班:大學畢業證書、大學成績單、碩士班第一學期成績單。
- (五) 攻讀博士學位計畫,含研究計畫之背景目的、研究方法及步驟。
- (六) 自傳。
- (七) 其他有利審查之資料,如論文、報告等。
- (八) 其他相關規定由各學位學程訂定之。

甄試方式得採應繳資料審查及面試,依每期博士班招生簡章辦理。

III. Applicants for direct admission to doctoral programs shall be recommended by two professors at the rank of Assistant Professor or above from the currently-enrolled

department/institute/college/degree program to apply to the Academy based on the following qualifications:

- (I) Undergraduate program students in the current graduating class, including applicants for early graduation, shall meet one of the following qualifications:
 - 1. An average academic grade of 75 or above.
 - 2. Ranked among the top 60% of the class/program.
- (II) Master's program students shall have completed their first semester of study with academic grades satisfying the criteria of academic excellence as follows:
 - 1. An average academic grade of 80 or above.
 - 2. Ranked among the top 60% of the class/institute/program.

Applicants shall submit an application with the following documents:

- 1. A completed application form (downloaded from the website of the Program).
- 2. Recommendation letters (from two professors of the original department/institute/college /degree program).
- 3. Undergraduate applicants: transcript.
- 4. Master's program students: bachelor's diploma, undergraduate transcript, transcript for the first semester of the master's program.
- 5. A study plan for pursuing the doctoral degree, that will include the research background, purpose, methods, and procedures.
- 6. An autobiography.
- 7. Other supporting documents (such as papers or projects).
- 8. Other documents designated by each degree program.
- Each program shall organize a screening examination in the format of review and interview in accordance with the doctoral program recruitment prospectus.

四、各學位學程辦理逕行修讀博士甄試得與博士班研究生入學考試同時舉行。

- IV. Each degree program may hold a screening examination for direct admission to its doctoral program concurrently with its regular doctoral program entrance examination.
- 五、各學位學程應將其甄審通過名單有關資料及甄試委員會會議記錄,依本校規定時程內提報 教務處彙辦相關簽核事宜。
- V. Each degree program shall submit its list of approved applicants with the meeting minutes of its screening examination committee and relevant documents to the Office of Academic Affairs according to the NCKU-designated schedule for further administration.
- 六、逕行修讀博士學位學生,有下列情形之一者,得申請轉入本學院原就讀學位學程或相關系、 所、院、學位學程修讀碩士學位,經本學院學位學程及轉入修讀系、所、院、學位學程會議 審查通過,陳請院長核定後,始得轉入碩士班就讀:
 - (一)因故中止修讀博士學位。
 - (二)未通過博士候選人資格考核。
 - (三)未通過博士學位考試且未符合第八點規定。

前項學生依據轉入碩士班之修業規定修讀完成碩士學位應修課程,提出論文,經碩士學位考 試委員會考試通過者,授予碩士學位,其修讀博士學位修業時間不併入修讀碩士學位最高修 業年限核計。轉入(回)碩士班後,不得再行申請逕行修讀博士學位。

- VI. Direct-admission doctoral students may apply for transfer to the master's program of the original degree program of the Academy or a relevant master's program of another department/institute/college/degree program under the circumstances approved by the original degree program of the Academy, the intended department/institute/college/ degree program, and the Dean of the Academy, as follows:
 - (1) Those who discontinue their study in the doctoral program for a specific reason.
 - (2) Those who fail to pass the Ph.D. candidate qualification evaluation.
 - (3) Those who fail to pass the Ph.D. degree examination and who fail to comply with Rule VIII herein.

After transfer to a master's program, those who have completed all required courses and thesis and who have passed the master's degree examination administered by the examination committee shall be conferred a master's degree. The duration of study in the doctoral program shall not be calculated as part of the maximum period of study in the master's program.

Such transfer master's students of direct admission are no longer eligible to apply for direct admission to doctoral programs.

七、逕行修讀博士學位學生修業期滿,通過博士學位候選人資格考核。但未通過博士學位考試, 其博士學位論文經博士學位考試委員會認定合於碩士學位標準者,得授予碩士學位。

- VII. At the expiration of the maximum study duration, direct-admission doctoral students who have passed their Ph.D. qualifying examination, but failed to pass their doctoral degree examination, shall be conferred a master's degree if the doctoral degree examination committee approves that their dissertation meets the academic standards of a master's degree.
- 八、他校生經核准並進入本學院逕行修讀博士學位學生,其在原校之學籍當然終止。
- VIII. Students admitted from other universities will lose their student status at their original universities upon their enrollment to a direct-admission doctoral program under the Academy.
- 九、逕行修讀博士學位學生,其在原系所、學位學程修讀之學分申請抵免事宜,悉依本學院研究 生抵免學分規定辦理。
- IX. Applications for waivers of course credits completed at the original departments/institutes/degree programs by direct-admission doctoral students shall be administered in accordance with *Regulations Governing Course Credit Waivers for Graduate Programs of the NCKU Academy of Innovative Semiconductor and Sustainable Manufacturing.*
- 十、 本規定未盡事宜,依相關規定辦理。
- X. Matters that are not specified in the Rules shall be administered in accordance with relevant regulations.
- 十一、本規定經院務會議通過後,送管理委員會通過後實施,報監督委員會備查,修正時亦同。
- XI. The Rules shall be approved by the Academy Affairs Council and the Management Committee, and ratified by the Supervisory Committee before taking effect. Amendments shall be processed accordingly.

These regulations were translated from the original Chinese. In the event of discrepancies between the two versions, the Chinese always takes precedence.
